GENERAL CONDITIONS FOR CHAMBER MEDICAL SERVICES

1- Definition of Chamber Medical Services (CMS):

a) The (CMS) covers only the initial recompression treatment of diving emergencies that need such treatment and only two HBO (in chamber) sessions, **BUT** it does **not** cover any transportation expenses to or from **Baromedical** chamber, hospitalization or further hyperbaric oxygen therapy sessions (HBO) if needed.

b) The (CMS) also does not cover any other diving incident or disease which does not need recompression chamber treatment.

2- The **Diving Center** acknowledges and agrees that **Baromedical** does not provide liability insurance cover for the **Diving Center**, its personnel and joining divers, other than that specified as **Chamber Medical Services (CMS)** & hereby release any discharge and agrees to indemnify **Baromedical**, its directors, officers and employees from any liability of any kind, foreseen or unforeseen resulting from the **Diving Center** activities.

3- The **Diving Center** understands and agrees with the terms, limitations and conditions of the coverage of the **Chamber Medical Services (CMS)** being issued to the diving boat or joining divers on registration at the **Diving Center** prior to participation in any diving activity & transmitted to **Baromedical**. In the event of a diving incident, the **Diving Center** will provide **Baromedical** with a full Accident Report together on receiving the patient.

4- The **Diving Center** understands that **Baromedical** is providing a complementary membership coverage for the **Diving Center** own local Scuba diving instructors, dive masters and certified assistants similar to that issued to the joining divers as long as he or she is still in the employ of the **Diving Center**. Free-lancers are not included except those working for diving centers that prove to have supported (CMS) activities. In return, **Baromedical** expects that the **Diving Center** will do its best to support & promote the **Chamber Medical Services (CMS)** activities.

5- The **Diving Center** understands and agrees to bear any compensation and/or expenses, if any, arising from any act of promotion or support to the **Baromedical** activities, and **Baromedical** shall in no way be responsible for the payment of such expenses.

6- Exclusions:

The coverage of Baromedical CMS shall not extend to any expenses incurred as a result of:

- Commercial diving activities.
- Diving activities in areas in which such activities are prohibited.
- Diving activities during certified pregnancy.
- Diving activities below the depth of 40 meters except for certified Technical divers.
- Diving activities outside the stated territory.
- Solo diving except for certified Technical divers.

And shall not apply to:

- Persons over the age of 70.
- Alcoholics.
- Drug addicts.
- Persons suffering from mental disorders.
- Uncontrolled diabetes patients.
- Asthmatic patients.
- Epileptic patients.

- 7- The Agreement for **CHAMBER MEDICAL SERVICES (CMS)** shall be construed in accordance with the Egyptian law, and in all matters relating there to, the parties shall remit any dispute arising out of or in connection with the interpretation or the execution of this Agreement to the jurisdiction of the courts of the Arab Republic of Egypt.
